REQUIREMENTS FOR HEALTH CARE FACILITIES

REQUIREMENTS FOR HEALTH CARE FACILITIES

- a) Accreditation by NHIA
- b) Possession of professionals with relevant academic qualifications
- c) Registration with the relevant regulatory body
- d) Possession of the current license to practice
- e) Appropriate facility for service delivery
- f) Registration by State authority (PHIMA).

Facility and Personnel Requirements for Primary Health Care Provider Public and private Hospitals should have the following:

- a) Accreditation by NHIA
- b) At least one Medical Practitioner
- c) At least five Registered Nurses/Midwives and CHEWS
- d) At least two Hospital Assistants
- e) At least one administrative staff and secretarial duties
- f) At least one medical Records
- g) At least one Medical Laboratory Technician
- h) At least one Pharmacy Technician

Health Centres

Primary Healthcare centres should meet the standards as set by the National Primary Health Care Development Agency

Nursing and Maternity Homes

- a) Proof of access to Medical Practitioner
- b) At least two registered nurses/midwives
- c) At least two hospital assistants or CHEWS

- d) At least one administrative staff for medical records and secretarial duties
- e) Registration with the state regulatory bodies

Facility and Personnel Requirements for Secondary Health Care Providers.

This level of health care is to have facilities for out-patient and inpatient services for General, Medical, Surgical, Pediatric, and Maternal care etc. The wards divided strictly into gender compartments.

A facility must be accredited as secondary Healthcare provider and must possess accreditation for Pharmacy, Laboratory and Operating theatre.

Minimum Requirements for Surgery

- a) Consultant Surgeons
- b) Peri-operative nurse
- c) Anaesthetic personnel (doctors/nurses)
- d) Intensive Care Nurse or Accident and Emergency Nurse, Theatre technician
- e) Surgical Clinic
- f) Male and Female Surgical Ward
- g) Operating Theatre

Minimum Requirements for Internal Medicine

- a) Consultant Physicians
- b) Qualified Nurses
- c) Medical Out-patient Department

Minimum Requirements for Dental Clinics

- a) Dental Surgeon
- b) Dental Therapist
- c) Dental Technologist
- d) Dental Clinic

Minimum Requirements for Ear, Nose and Throat (OTORHINOLARYNGOLOGY)

All specialty facilities must have registration with their relevant regulatory bodies

- a) ENT Surgeon
- b) ENT Nurse
- c) Equipped Clinic

Minimum Requirements for Ophthalmology

- a) Consultant Ophthalmologist/s
- b) Ophthalmic Nurse/s
- c) Equipped clinic

Minimum Requirements for Optometry

- a) Optometrist
- b) Ophthalmic Technician

Minimum Requirements for Pharmacy

- a) Pharmacist
- b) Pharmacy Technician where applicable
- c) Sales Personnel where applicable

Minimum Requirements for Medical Laboratory Services

- a) Medical Laboratory Scientist
- b) Medical Laboratory Technician
- c) Medical Laboratory Assistant

Minimum Requirements for Radiography

- a) At least a part time Radiologist
- b) Radiographer
- c) Radiological Centre
- d) Premises duly registered with the Government of the State in which the facility operates as an X-ray Centre.

Minimum Requirements for Physiotherapy

Registered Physiotherapists and other Medical Rehabilitation Therapists.
